Old Business

- Concealed Weapons
 - E-mail sent regarding letter Bishop Taylor sent regarding concealed weapons law

 - There was a question in regards if church premises included other buildings on church property

 - Discussed may be better idea to temporarily wait until more is known about the new building project

 - Report submitted was for July 2012-April; fiscal year is July 1 – June
 - Approximately \$12,000/month is received monthly into the parish ,
 - Fr. William would like to see a comparison of last and this year's receipts and expenses
 - Report need to be reviewed in 2-3month increments
 - As of meeting checking account had approximately \$50,494, Building Fund approximately \$17,762 and savings account as of March 31, 2013, approximately \$18,105
